AGREEMENT

ABOUT COOPERATION IN THE SPHERE OF TELEVISION AND RADIO BROADCASTING

BETWEEN THE COUNCIL FORRADIO AND TELEVISION BROADCASTING OF CZECH REPUBLIC AND THE NATIONAL COMMISSION ON TELEVISION AND RADIO OF REPUBLIC OF ARMENIA

Introductory

The Council forRadio and Television Broadcasting of Czech Republic, in the face of the Council's chairman Ivan Krejci, from the one side and the National Commission on Television and Radio of Republic of Armenia, in the face of the Commission's chairman GagikBuniatyan, from the other side (in the case of referencing together - Sides) signed this agreement with the aim to strengthen and develop the cooperation between the Council for Radio and Television Broadcasting of Czech Republic and the National Commission on Television and Radio of Republic of Armenia, that will foster the functional performance of the authorities of the Sides as well.

Taking into consideration the circumstance that, for realizing an effective regulation of the legislation and other authorities in the field of television and radio broadcasting, it is necessary an exchange of the experience, information and permanent consultation and basing on the mutual respect, confidence and on the collegial principles, the Sides acting within their jurisdiction agreed that:

Article 1

The Sides can exchange the information concerning the legal system that is in force in the sphere of broadcasting, criteria, processed methods and methodology, with the aim to improve the comprehension of the laws and regulation, that concern the television programs, making and duration of the advertisings, as well as the other sides of the audiovisual sphere.

Article 2

The Sides will exchange the delegations, will inform each other about conventions, seminars, training courses, symposiums and other upcoming events, inviting each other to seminars or other training programs, that will be organized by one of the Sides or by the third person or organization that will be representing one of the Sides.

Article 3

The Sides can regularly consult about the questions of the common interests, can exchange with the experience that they got in the field of national broadcasting.

Article 4

The results that were achieved due to the joint collaboration are considered to be a joint property. The limits for publishing the joint results will be used, only when it is provided by the national legislation, as well as when there is a preliminary agreement.

Article 5

The information provided by the Article 1 of this Agreement can only be published only in the case of the written agreement between two Sides.

Article 6

Changes and supplements in this Agreement can be done only in the case of the additional written agreement between the Sides.

Article 7

The Sides accept that this document is not foreseen for making legal relations between two Sides. However the Sides promise to use all reasonable and conscientious methods, for realizing all the obligations of this Agreement.

Article 8

The Agreement enters into force from the moment when it is signed and it is valid as long as when one of the Sides decides to cancel it. If one of the Sides considers it necessary to cancel the Agreement, then in 30 days before canceling the Agreement it must notify about the decision to the other Side. After 30 days expire the Agreement is considered canceled.
